Strategies are evolved to meet the needs of researchers (participation action research, funds)



At present the centre is carrying out the projects related to beggary and tobacco prevention. Easy approachability of the centre enables the students and scholars derive necessary support and guidance from the centre for doing research. Students are exposed to practice SPSS.



Curriculum development

The field collaborations help the college understand the field realities, market requirements and the competencies expected of the students. This understanding enables the college to review and revise the curriculum for all the programmes and bring necessary changes in the content and the methodologies of teaching.
